Circular Letter No. 24-1839

RE: Expansion of Medical and Indemnity Call Participation

The Minnesota Workers' Compensation Insurers Association, Inc. (MWCIA) has received notice from NCCI regarding their intent to expand the percentage threshold for Medical and/or Indemnity Data Call reporting from at least 1% market share in any one applicable state over the most recent three years (overall average equals 1% or more) to at least .5% market share in any one applicable state over the most recent three years (overall average equals .5% or more).

Once a carrier group meets the eligibility criteria, the carrier group is required to report for all applicable states in which it writes, even if an individual state's market share is below the threshold.

NCCI will contact the carrier groups that are now eligible to report Medical and/or Indemnity data due to the change in participation threshold. Impacted carrier groups will receive a letter from NCCI emailed to the group's signer of contract.

Newly eligible carrier groups will be required to report Indemnity data as of Fourth Quarter 2024, with Transactional Records and Quarterly Records due by March 31, 2025. Medical data will be required as of Fourth Quarter 2025, with data due by March 31, 2026.

No change is necessary for carrier groups that currently report Medical and/or Indemnity data.

Expansion of Medical Data Call Participation

NCCI is updating the participation eligibility percentage threshold for Medical Data Call reporting from at least 1% market share in any one applicable state over the most recent three years (overall average equals 1% or more) to at least .5% market share in any one applicable state over the most recent three years (overall average equals .5% or more).

Once an affiliate group meets the eligibility criteria, the affiliate group is required to report for all applicable states in which it writes, even if an individual state's market share is below the threshold.

NCCI will contact the affiliate groups that are now eligible to report Medical data due to the change in participation percentage threshold. Impacted affiliate groups will receive a letter from NCCI emailed to the group's signer of contract.

Newly eligible affiliate groups will be required to report Medical data as of Fourth Quarter 2025, with data due by March 31, 2026.

No change is necessary for affiliate groups that currently report Medical data.

NCCI's *Medical Data Call Reporting Guidebook* will be updated to reflect the new participation eligibility threshold.

In the future NCCI expects to continue expansion for participation in the Medical Data Call requiring all affiliate groups, regardless of market share, to report Medical data. Future communications will provide notice and dates with adequate lead time before reporting will begin.
